Overview

At GreenBox Systems LLC ("GreenBox," "we" or "us"), we respect the privacy of visitors using our website.

Individuals have the right to be informed about the collection and use of their personal data ("privacy information"). For privacy information please see our <u>Privacy Notice</u>.

What is a Cookie?
